PUBLIC HEARING

-Application from Larry Daniels, Tax Map No. 77A3-10-21; Auto Sales and Service A public hearing was opened to receive public comment on the above application. There being no registered speakers, the public hearing was closed.

The Commission discussed the application with the applicant. Mr. Daniels asked if AEP could be notified to look at the street lighting around his business.

Commissioner Dodson asked if Mr. Daniels could really get 50 cars in the parking area. Mr. Daniels stated that he felt that he could, saying he planned on blocking two of the four entrances to the property.

Commissioner Hermansen asked if the customers would have to back out onto the highway. Mr. Daniels stated that no, the clients would be able to pull through the business and leave in a forward direction.

Commissioner Bradshaw asked about his hours of operation. Mr. Daniels stated that he planned to be open Monday, Tuesday, Thursday, Friday from 10- 4 or 9-5; with a half day on Saturday.

The Commission then discussed conditions. Commissioner Hermansen made a motion to recommend approval of the application to the Board of Supervisors with the following conditions:

- 1) No more than 49 vehicles for sale at anytime
- 2) No obtrusive lighting
- 3) Proper disposal of all automobile fluids
- 4) No overnight, outside storage of inoperable vehicles to exceed three consecutive nights
- 5) Limit hours of operation to daylight hours
- 6) Ensure sight distance at Intersection

Commissioner Chewning seconded the motion. It passed unanimously.
