Secretary Cagle called for a motion to recommend disapproval of the rezoning application, a motion was made by Commissioner Kidd to recommend that the Board of Supervisors deny the application for Tax Map No. 77-A-24 to be rezoned from Agricultural to Commercial due to the proposed use not conforming with the comprehensive plan of the county and the official policies adopted in relation thereto; a second was provided by Commissioner Hermansen.
