- 004** Proposed Zoning Ordinance Definition Change (Sec. 62-1: Definitions)  
Existing:

*Professional office* means an office in which business is conducted by the following professions: physicians and surgeons, lawyers, members of the clergy, architects, engineers, or other persons holding advanced degrees. The term is not intended to include insurance agents, insurance adjusters, realtors, photo studios, beauty parlors, barbershops, dance schools, business schools, or any establishment engaged in sales or trade.

Proposed:

*Professional office* means a building or structure used for office space for businesses, non-profits, and/or other professional service operations. Professional Offices may include regular visits and interactions with clients, customers, or patrons on-site. Examples include accountants, lawyers, architects, engineers, travel agents, data processing centers, clerical, or similar office environment.
