004 Amendment of the FY23 County and School Budget. The proposed amendments to the FY23 budgets are to appropriate additional unbudgeted federal, state, and grant revenues received by the Bland County Public School Board (\$1,400,000 State School Facility Improvement Funds, food and ESSR funds) and the County of Bland (\$42,000 Opioid Settlement Funds to DARE & Bland County Rescue Squad; \$196,000 Sheriff's Department ARPA Funding; \$30,000 of Courthouse Security Funds to Fund 100 County Administration) during FY23. Since this amount exceeds 1% of the overall County Budget, a public hearing is required pursuant to Code of Virginia, § 15.2-2507.
