## PUBLIC HEARING CONDITIONAL USE PERMIT

Mr. Joel Cagle, Planning Commission Secretary updated the board with the Planning Commission's approval for the conditional use permit application for a recreational facility for Tax Map No. 93-A-27 & 31A with the following conditions:

- 1. All Local, State and Federal regulations shall be complied with.
- 2. This permit is expressly conditioned upon construction starting within two (2) years of its approval by the Bland County Board of Supervisors. Should construction not begin with two years, this permit shall be considered null and void. If reduced load weight limits on a bridge or bridges adjacent to the site demonstrably delay construction, the start date for construction maybe extended for the period of such demonstrated delay.
- 3. An approved entrance permit shall be obtained from the Virginia Department of Transportation.
- 4. A division and/or boundary fence shall be maintained and paid for partially, up to one half cost, by permittee in accordance with and as required by Virginia Code 55.1-2823. It was recommended that condition 4 be amended to remove "partially, up to" and replaced with "at".

Chairman Stephen Kelley opened the public hearing.

Mr. Bob Munsey expressed concerns about the wooded area and the need for citizens to obey traffic laws. He asked the question concerning why the designation as to recreational for this zone.

Mr. Cagle stated that agricultural zone allows for the designation of a recreational to be its zone. Chairman Stephen Kelley closed the public hearing.
