**004 Sec. 54-1. - State laws adopted by reference. (*The additional amendments are in bold italics*)**

(a) Pursuant to the provisions of Code of Virginia, § 46.2-1313, as amended, all of the provisions and requirements of the laws of the state contained in Code of Virginia, § 18.2-266 et seq., as amended, except those provisions and requirements which by their very nature can have no application to or within the county, are hereby adopted and incorporated by reference, made a part of this chapter, and made applicable within the county as though fully set forth herein.

(b) It shall be unlawful for any person to commit upon the highways of this county violations relative to the operation of motor vehicles as described in Code of Virginia, §§ 46.2-100 through 46.2-114, 46.2-300, 46.2-302, 46.2-303 through 46.2-322, 46.2-341.1 through 46.2-341.34, 46.2-346 through 46.2-350, 46.2-371 through 46.2-388, 46.2-606 through 46.2-613, **46.2-617**, 46.2-618, 46.2-645, 46.2-646, **46.2-707**, 46.2-715, 46.2-716, 46.2-722, 46.2-800 through 46.2-946, 46.2-1000 through 46.2-1156, **46.2-1156.1**, **46.2-1158**, **46.2-1162**, **46.2-1172 through 46.2-1173**, and **46.2-1242**, **46.2-1247 through 1253** which are adopted herein by reference and made a part of this chapter.

(c) The punishment upon conviction shall be that of misdemeanors as established by Code of Virginia, tit. 46.2, as amended, and by Code of Virginia, §§ 18.2-12, 18.2-27 and 18.2-266 et seq., as amended.
