COVID-19 Updates

County officials are continuing to monitor and make adjustments to operations and schedules associated with the global pandemic COVID–19. Plans are being developed regarding the opening of several county operations such as the library, farmers' market, canneries, and Wolf Creek Indian Village. Please note that adjustments may be made rapidly depending on federal and state orders. Therefore, the most up to date information about local governmental operations associated with COVID-19, are located on the County website: www.blandcountyva.gov or call 688-4622.

Here are a few updates:

Wi-Fi Hotspots: Multiple internet hotspots are either operational or being planned. Current operational hotspots are located at the Library, Fairgrounds, Hollybrook Community Park, and the Courthouse. Upgrades are being planned for the Ceres Park and Rocky Gap Park and should be operational soon. Additional hotspots are being planned.

Recycling: Effective June 1st, Bland County will be suspending curbside recycling and recycling bin collections until further notice. COVID-19 has had devastating impact on the already struggling recycling market. Communities across the region have struggled in recent years to find places to accept recycled materials and now many communities are forced to suspend their recycling programs. Bland County will continue recycling tires and electronics on designated days. Large items and white goods will also still be collected in the first full week of the month on your regular trash pickup date. If you have questions regarding the recycling program please call the Bland County Public Works office at 688-4622.

Bland County Library Renovations

At the January meeting of the Library Board of Trustees, the Board voted to pursue renovation projects at the library. This spring, while closed due to COVID-19, library and county staff prepared the library for new paint and carpeting. Approximately 30,000 books loaded into 400 boxes, 28 units of metal shelves, countless computers and office supplies were moved into storage while the work was underway.

Renovation is now complete and library staff is working to reshelf books and prepare for reopening.

Board of Equalization Hearing

Public notice is hereby given that the Board of Equalization for Bland County will meet on the days hereafter listed for the purpose of hearing complaints of inequalities including errors in acreage. Upon hearing such complaints, either oral or written, the Board will give consideration AND INCREASE, DECREASE OR AFFIRM such real estate assessments. Before a change can be granted, the taxpayer or his agent must overcome a clear presumption in favor of the assessment. The taxpayer or agent must provide a preponderance of the evidence that the assessment of the property is not uniform with the assessments of other similar properties or that the property is assessed in excess of its fair market value.

Cooling assistance provides purchase or repair of cooling equipment and/or payment for electricity to operate cooling equipment. To be eligible, a household must contain at least one vulnerable individual who is age 60 or over, is living with a disability, or is under age 6.

Applications are accepted online at <u>www.commonhelp.virginia.gov</u>, through the Enterprise Customer Service Center at 1 -855-635-4370, and at local departments of social services from June 15 through August 15. Assistance is based on the availability of funds.

Eligibility criteria for assistance include:
