### REVALIDATION FOR LAND USE

With the 2020 general reassessments notices mailed, it is now time to revalidate your land use. Everyone that is in the land use program is required to sign a new application for each parcel and pay the revalidation fee in order to continue in the program for tax year 2020. Taxpayers may come to the Commissioner of Revenue's Office, download forms from our website or call and we will mail you an application. The deadline to renew 2020 applications will be January 2, 2020. If you have any questions, please call the Commissioner of Revenue's Office at 276-688-4291.

#### General Reassessment of Real Estate

Bland County has retained Pearson's Appraisal Service, Inc., to perform the County's 2020 General Reassessment of real estate, which will become effective on January 1, 2020. The County is currently on a 6-year reassessment cycle. The Code of Virginia, 1950, as amended, mandates that each locality periodically perform a general reassessment of real estate to determine each property's fair market value and to equalize each property's value in relation to similar properties.

Bland County Treasurer's office is selling dog tags for 2020. Current tags expire on Dec. 31, 2019.

Real Estate and Personal Property tax taxes are due on December 5, 2019.

Prepayment toward taxes can be made anytime during the year. If you would like additional information, please contact the Treasurer's office @ 688-3741.

Crisis Assistance: November 1 through March 15 for equipment related assistance and security deposits.


First workday in January through March 15 for purchase of primary home heating fuel and payment of primary heat utility bills.
